#### The Objects of ADIPS Limited

The dominant purpose and principal activity of ADIPS is to promote the prevention or control of diabetes mellitus as it relates to pregnancy in women.

The Company aims to further its dominant purpose by:

- developing or assisting in developing treatment for the use in the prevention or control of diabetes mellitus in pregnancy;
- (ii) engaging and encouraging, promoting and facilitating research, or assisting in the research into the causes, prevention and treatment of diabetes mellitus in pregnancy;
- (iii) promoting among members of the medical profession, scientists and others the free exchange of knowledge with respect to diabetes mellitus related to pregnancy;
- (iv) developing in association with other interested bodies, education methods designed to give those who have diabetes mellitus as it relates to pregnancy a better understanding of their condition;
- (v) improving standards of diagnosis and management of diabetes mellitus before, during and following a pregnancy;

- (vi) disseminating to the public accurate information about diabetes mellitus related to pregnancy and the risk factors associated therewith;
- (vii) promoting research related to diabetes mellitus related to pregnancy by individuals, hospitals, clinics, universities and other institutions and organisations;
- (viii) being responsible for statements relating to the professional and research aspects of diabetes mellitus related to pregnancy (both medical and scientific); and
- (ix) taking such other measures and encourage such service as will enhance the welfare of individuals having diabetes mellitus as it relates to pregnancy.

#### **Annual Scientific Meeting**

Sadly, there is no Annual Scientific Meeting to report on this year due to the COVID-19 pandemic. It was a difficult decision for the organising committee and the ADIPS Board to cancel the 2020 ASM but I am sure you will all agree that it was not feasible in the current environment. We are, however, planning to host a pregnancy session at the ADC "Virtual" conference in November this year and we hope you will attend.

#### **The Society**

The Society currently has a membership of around 275 people. We continue to welcome all health professionals involved in the care of women with diabetes in pregnancy as members, and this extends to our Annual Scientific Meetings also.

#### **Management Guidelines**

I am very pleased to announce that the Management guidelines for pre-existing diabetes in pregnancy have been accepted for publication in ANZJOG. They will appear in the journal next month. Following their publication, we will post the guideline on our website. They will also be officially launched and discussed at a session in the ADC meeting in November this year. I would like to officially thank Leonie Callaway who conceived the update of the guidelines and Victoria Rudland who brought the guidelines to fruition. Thank-you to the many other ADIPS members who contributed to these guidelines.

#### **Website Upgrade**

We are currently working on upgrading the ADIPS website to make it more contemporary and to have greater functionality across all devices. It has been many years since we first developed

our website and the redesign should assist our members to use the website more easily.

#### **ADIPS-Novo Nordisk Research Grants**

Three ADIPS-Novo Nordisk research grants, each worth \$6,000, have been offered annually for a number of years in the areas of Clinical Research, Scientific Research and Educational Research. Given the ASM was cancelled this year, we were unable to secure support for these grants in 2020. However, we look forward to engaging with Novo Nordisk or other organisations in the future to continue this grant scheme.

#### **Future meetings**

In 2021, the ADIPS ASM will be held with SOMANZ in a "fully virtual" format from 23-25th July so please save this date. We will continue to update you as the program develops. With the uncertainty around international travel and domestic travel for health professionals, the organising committee and the Board agreed that a fully virtual meeting was necessary to avoid last minute changes in these uncertain and changing times.

We are yet to appoint the Organising Committee so please contact us if you are interested in being involved.

ADIPS have put forward an Expression of Interest to host the IADPSG meeting in Australia in early 2022. We will keep you informed of the progress on this.

### **ADIPS Limited Finance Report 2020**

ADIPS Limited produced a surplus of \$20,833 for the operating year 1 July 2019 to 30 June 2020, representing a larger gain compared to the previous financial year that had a \$4,074 profit.

The Society income is largely derived from membership fees and the profit from the Annual Scientific Meeting each year that is held with ADS/ADEA or SOMANZ. The Society sustained an overall loss in four of the five years between 2013 – 2017 prompting a rise in membership fees in 2017 and 2019.

The ADIPS annual membership fees remain traditionally low compared to other specialist medical society fees. Since 2017, the fee structure has been tiered to meet the diverse incomes of ADIPS members. The Board will continue to monitor membership fees annually and amend as necessary to assist with covering some of the operational costs of running the Society.

The net assets of the Society in 2020 were reported as \$145,981 compared with \$125,148 in the 2018-19 financial year. The Society assets have remained relatively stable over the past 10 years apart from 2015 when there were legal fees associated with the move to a Public Company.

The financial outcome for 2020 was higher than usual and a pleasing result. The increased profit can be attributed to the profit from the 2019 ASM held in Sydney, as well as the assistance provided by the Australian Taxation Office with business cash flow boost payments and JobKeeper support payments.

The profits in 2020 will assist in buffering the anticipated losses in


the forthcoming 2021 year where there will be no income from the ASM, and indeed some costs associated with cancellation of the Annual Scientific Meeting in July 2020 due to COVID-19.

The trend in the Society assets over the past 10 years are represented in Graph A.

The ADIPS Limited finances are managed by the Finance, Audit and Risk Committee as opposed to the traditional Treasurer role. The two directors during the 2019-20 financial period were Janet Schweda (Lagstrom) and Cynthia Porter, who were supported by Ms Suzie Neylon, Company Secretary and Executive Officer who manages the day to day transactions. The Committee oversee the finances and make recommendations to the Board. Janet Schweda (Lagstrom) will continue on this committee for 2020-21 and will be joined by Julia Zinga who joined the Board in September 2020.

The Society financial statements for 2020 were prepared by Tinworth & Co, Chartered Accountants in North Sydney. The report is a summary of the full financial report that is available in the member area of the ADIPS Limited website or upon request.

### **Membership**

The Society currently has 290 members listed on their database with 188 currently financial. The implementation of online payments introduced in 2018 has made an improvement in timely payments, however, a substantial number remain unfinancial and will be removed from active membership as many were in 2019.

The membership is composed of a variety of health professionals and researchers with an interest in diabetes in pregnancy including Endocrinologists and other Physicians, Obstetricians, General Practitioners, Research Scientists, Diabetes Educators, Dietitians, Midwives, Podiatrists, Pharmacists, Registrars and Advanced Trainees as well as other interested health professionals.

The benefits of membership include:

- Discounted registration fees to attend the Annual Scientific Meeting
- Opportunities to participate in the organisation of the Annual Scientific Meeting
- Able to apply for a variety of grants and awards including the Graz Clock Award, Emerging Investigator Award, Allied Health Presentation Award and Outstanding Poster Award available at the Annual Scientific Meeting
- Opportunity for junior members to apply for Educational Travel Grants to attend the Annual Scientific Meeting
- Access to ASM invited speaker presentations post conference
- Access to apply for the ADIPS-Novo Nordisk Research Grants for Scientific, Clinical & Education Research
- Receive invitations to comment and participate in review of major clinical guidelines

- Receive regular electronic newsletters containing updates on the latest news and activities of the Society including the wider diabetes in pregnancy community
- Opportunity to nominate for a director position on the board of directors
- Participate in other research and educational activities and projects conducting by the Australasian Diabetes in Pregnancy Society Limited.

The fees for membership for 2020 were:

### **Tier 1 – Medical Practitioners - \$198.00** (includes \$18 GST)

This tier includes independent medical practitioners in current clinical practice (eg. Physicians, Obstetricians, General Practitioners etc).

### Tier 2 – Researchers, Nurses, Allied Health and Registrars - \$110.00 (includes \$10 GST)

This tier includes Basic Researchers, Registered Nurses, Diabetes Educators, Midwives, Dietitians, Podiatrists, Registrars, Advanced Trainees, and any other health professional (medical or scientific) working in diabetes in pregnancy.

#### Tier 3 - Students - \$99.00 (includes \$9 GST)

This tier includes medical and scientific students who are enrolled in a training program and have not graduated and are not earning a salary over \$30K.


The fees for international members were the same but excluded the GST component. The membership year is from March to March each year.

### Membership by State


The distribution of the total membership throughout Australia and New Zealand is represented in Graph 1 with 32% in NSW. 24% in Victoria, 20% in Queensland, 7% in Western Australia. 6% in South Australia. 2% in the Northern Territory, 2% in Tasmania and 1% in the Australian Capital Territory. 6% of the total membership are in New Zealand.



## Membership by Occupation

Based on the current information provided to ADIPS by its members, the following broad category occupations are represented: Medical Practitioners including Endocrinologists, Other Physicians, Obstetricians, GPs, and Trainees (55%), Diabetes Educators, Dietitians, Midwives, and Nurse Practitioners (40%), Scientific Researchers (3%) and other Allied Health (2%). ## ADIPS Diabetes in Pregnancy Clinical Audit Programme

Professor David Simmons, Board Director Joined the Board on 27 August 2016

The Australasian Diabetes in Pregnancy Society published a successful pilot study of 3 approaches to clinical audit (paper, stand-alone electronic, networked electronic) across 9 different clinical settings (rural, urban, large proportion of indigenous, New Zealand) linked with a Benchmarking Centre in 2007 [Australian and New Zealand Journal of Obstetrics and Gynaecology 2007;47:198-206]. With the Australian National Diabetes Strategy Goal 4 being to "Reduce the impact of pre-existing" and gestational diabetes in pregnancy", the need to re-establish the audit programme to monitor achievement of the goal, became clear, and ADIPS volunteered to undertake this task. In 2018, the ADIPS Board established the Diabetes in Pregnancy Clinical Audit Programme Working Group which has developed a revised dataset, a process for de-identification of patients and sites, a publication protocol and proposed central data analysis and reporting site protocols. The need for the audit was presented to the Federal Minister, the Hon Greg Hunt at the National Diabetes Forum in October 2018. After the Forum, the Australian Institute of Health and Welfare (AIHW), indicated their interest in assisting with the data repository and to align the ADIPS dataset with other Australian Datasets. However, AIHW also advised that funding would be required to undertake the work.

Since this time, ADIPS has led the development of a proposal for a Clinical Quality Register with the Australian Commission on Safety and Quality in Health Care. The AIHW has provided a detailed proposal for undertaking the work with governance provided by ADIPS with the support of other key organisations. The proposal is still being worked

up with the Australian Commission on Safety and Quality in Health Care.

As the approach was expected to take time to complete, ADIPS embarked upon a pilot Diabetes in Pregnancy Clinical Audit Programme. Expressions of interest were requested from ADIPS members and 11 volunteer sites had existing data for women with GDM and/or pre-gestational diabetes in pregnancy. All sites were able to provide deidentified data under existing approvals. The audit involved electronic data transfer using a Standard Format Excel Spreadsheet format with Data Field Definitions developed for this purpose. The audit is now complete with Jincy Immanuel a student at Western Sydney University collating the data as the Trusted Third Party (TTP), checking there were no site identifiers and then forwarding to Professor Flack at Bankstown-Lidcombe Hospital who has cleaned the data and through the TTP addressed any questionable data items. Overall, after cleaning data from 10,144 women were received including 435 with type 1 diabetes, 1013 with type 2 diabetes and the remainder gestational diabetes mellitus. A paper describing the benchmarking process and site variation is being drafted.

## American Diabetes Association's Norbert Freinkel Award Recipient for 2020

### Professor David Simmons MA (Hons, Cantab) MD (Cantab) FRCP (UK) FRACP FRGS has

been selected to receive the American Diabetes Association's 2020 Norbert Freinkel Award, given in the memory of Norbert Freinkel (1926-1989), a dedicated and insightful investigator, writer and thought leader. The Norbert Freinkel award honours researchers who have made outstanding contributions - including scientific publications and presentation - to the understanding of diabetes in pregnancy.

Distinguished Professor David Simmons currently serves as Professor of Medicine at Western Sydney University, Head of the Endocrinology Department at Cambelltown Hospital, Director of the South Western Sydney Diabetes, Obesity, Metabolism and Translational Unit (DOMTRU) and Director of SPHERE Diabetes Obesity Metabolism Academic Group. He is also a Professorial Fellow at University of Melbourne, Visiting Professor at University of Orebro, Sweden and Guest Professor at First Affiliated Hospital of Zhengzhou University, China.

He has authored more than 300 publications and has supervised countless PhD students, Honours students and medical students.

Professor Simmons research career has spanned more than 30 years. As a junior doctor in Coventry, England, he established the Coventry Diabetes Study, a household survey that subsequently became his doctorate. On moving to South Auckland, New Zealand, he was mentored by the late Dr David Scott, who established one of the first diabetes in pregnancy clinics and a community-based programme to prevent diabetes complications among local Pacific and Maori people. This led him to commence research into the epidemiology of diabetes in pregnancy. Over the subsequent decades, he has published and presented prolifically in this field.

Today, Professor Simmons research is driven by his early work and is centred around the prevention, diagnosis and management of diabetes in pregnancy. His most recent research includes a



randomised controlled trial of gestational diabetes prevention (DALI) and a randomised controlled trial of early pregnancy gestational diabetes diagnosis and treatment (TOGOGM). Both studies address critical research questions, the results of which will guide the clinical care of women with diabetes in pregnancy.

He collaborates widely and has also recently been involved in the MiTY study (PI Denice Feig), CDC4G study (PI Helena Fadl), and the DCAPP (Diabetes Contraception and Pre-Pregnancy Programme) study in Sweden. He has been involved in population-based programmes including pre-pregnancy care programs, integrated diabetes care programmes across both primary and secondary care, diabetes care in young persons (18-25 years old) and diabetes detection and prevention projects in Tonga. The depth and breadth of his research career is immense.

Professor Simmons has had numerous appointments on international committees including acting as chair of the diabetes in pregnancy writing group for the International Diabetes Federation Atlas Committee, membership of the WHO working group

on the Technical Report on screening for GDM and Chief Technical Advisor Tongan Gestational Diabetes Taskforce. In Australia, Professor Simmons was Chair of ADIPS from 1998-2002 and returned to the board of ADIPS in 2016 and is a current director. He remains Chair of the National Diabetes in Pregnancy Audit Programme which aims to establish a benchmarking program for diabetes in pregnancy in Australia.

Under normal circumstances, Professor David Simmons would be recognised with the honour of the Norbert Freinkel award at the ADA's 80th Scientific Sessions and would deliver the Norbert Freinkel Award Lecture. In view of the COVID-19 pandemic, alternative arrangements will be made.

On behalf of a very proud ADIPS community, I would like to congratulate Professor David Simmons on this award. He joins an esteemed group of researchers who stand on the shoulders of a giant!
