Australasian Diabetes in Pregnancy Society Limited (ADIPS)

The Australasian Diabetes in Pregnancy Society (ADIPS) is a public company limited by guarantee. It is a specialist medical society with a professional membership of medical graduates, health professionals and scientists interested in diabetes mellitus as it relates to pregnancy or who have a primary role in professional diabetes in pregnancy care in women. Its premier annual event is its annual scientific meeting which attracts over 250 health care professionals facilitating and promoting the free exchange of knowledge with respect to diabetes in pregnancy.

The Objects of ADIPS

The dominant purpose and principal activity of ADIPS is to promote the prevention or control of diabetes mellitus as it relates to pregnancy in women.

The Company aims to further its dominant purpose by:

- (i) developing or assisting in developing treatment for the use in the prevention or control of diabetes mellitus in pregnancy;
- (ii) engaging and encouraging, promoting and facilitating research, or assisting in the research into the causes, prevention and treatment of diabetes mellitus in pregnancy;
- (iii) promoting among members of the medical profession, scientists and others, the free exchange of knowledge with respect to diabetes mellitus related to pregnancy;
- (iv) developing in association with other interested bodies, education methods designed to give those who have diabetes mellitus as it relates to pregnancy a better understanding of their condition;
- (v) improving standards of diagnosis and management of diabetes mellitus before, during, and following a pregnancy;
- (vi) disseminating to the public accurate information about diabetes mellitus related to pregnancy and the risk factors associated therewith;
- (vii) promoting research related to diabetes mellitus related to pregnancy by individuals, hospitals, clinics, universities and other institutions and organisations;
- (viii) being responsible for statements relating to the professional and research aspects of diabetes mellitus related to pregnancy (both medical and scientific); and
- (ix) taking such other measures and encourage such service as will enhance the welfare of individuals having diabetes mellitus as it relates to pregnancy.

Report from the President and Board Chair

Arianne Sweeting, President and Board Chair from 21 September 2020

The fully virtual 2021 Annual Scientific Meeting held jointly with SOMANZ in July this year was a great success. The meeting attracted our largest number of delegates to date with 560 virtual attendees including 20 speakers and 12 exhibitor registrations. Further details of our premier annual event can be found later in this Annual Report.

The Society currently has a membership of 315 and we continue to welcome all health professionals involved in the care of women with diabetes in pregnancy as members, and this also extends to attendance at our Annual Scientific Meetings.

Please continue to encourage your colleagues to consider joining ADIPS so they can utilise the many benefits we provide to our members.

We launched the new ADIPS website in 2021 including an updated logo reflecting a more contemporary design, updated content, and greater functionality across PC, Mac, Tablets and smart phones. It has been many years since we first developed our website and with advancing technology this upgrade was long overdue. We will continue to add more content to benefit our members and please provide feedback on current and potential additional content.

The ADIPS Board have been involved in a number of activities throughout 2021 including:

- Providing feedback and endorsing the revised NDSS “Having a Healthy Baby” booklets
- Providing input and feedback on the pregnancy section of the ADEA Diabetes Pathway Project
- Supporting ADEA in lobbying for Medicare rebates for dietetics and diabetes education in diabetes in pregnancy
- Partnering with ADS/ADEA and APEG to produce a joint position statement on utilisation, access and recommendations regarding technologies for people living with type 1 diabetes
- Supporting members by partnering on MRFF grant applications with in-kind support
- Participating in the NDSS product review commissioned by the Federal Government
- Participating in the RACP 2021 Congress by providing two diabetes in pregnancy-based lectures
- Holding a joint Diabetes in Pregnancy symposium at the ADC Congress in August 2021
- Dr Sarah Price continues to represent ADIPS on the Australian Diabetes Data Network evaluating CGM in pregnancy

- Participating in the AACB Glucose Preanalytical Group. A position statement is expected to be produced.
- Professor David Simmons continues to work on the national diabetes in pregnancy clinical benchmarking program with the working group producing a publication in May this year.

We were successful in our quest to secure funding in 2021 for the ADIPS Novo Nordisk Research Grants and offered two (2) grants at A\$10,000 each. Applications were invited in the broad areas of Clinical, Scientific, or Educational Research. We are very grateful to Novo Nordisk for their support again in 2021.

We announced two new Honorary Life Members to ADIPS in 2021. I would like to again acknowledge and congratulate Professor Jeff Flack and A/Professor Glynis Ross for their distinguished contribution to ADIPS and diabetes in pregnancy.

Diabetes Australia has been working towards unification in the diabetes community by bringing together organisations that advocate for people with diabetes as well as diabetes health professionals, including diabetes researchers. The major driver for the unification is to have one strong voice with Government.

The Diabetes Australia State and Territory organisations of NSW-ACT, TAS, and QLD as well as the Kellion Foundation have joined DA National as one organisation while DA-VIC remains engaged in the staged unification process. Notably, ADS and ADEA have both passed resolutions at their recent AGMs to have formal affiliation with Diabetes Australia. Diabetes Australia is currently drafting an MOU to send to ADIPS for consideration. Discussions on the unification proposal between ADIPS and Diabetes Australia will recommence in the New Year. We will keep the membership informed as we receive further information. It is expected that ADIPS would retain its National Board, brand, logo, financial independence, non-for-profit

and charitable status, membership, grants and awards, activities, educational events, guidelines, position and consensus statements.

As advised at the AGM, ADIPS put forward an expression of interest to host the International Association of Diabetes in Pregnancy Study Groups (IADPSG) annual meeting in Australia in 2022. I am pleased to advise that our bid was successful and ADIPS will host the IADPSG in a joint meeting in Sydney in November 2022. David Simmons, Suzie Neylon and myself have met with Fidelma Dunne, the IADPSG President, and Robert Lindsay, the IADPSG Secretary and set the dates for 17-20 November 2022 with the meeting to be held at the Sheraton Grand Hyde Park Sydney. In addition to the IADPSG-ADIPS Scientific Steering Committee, the Local Organising Committee will include Professor Dharmintra Pasupathy, Robyn Barnes, Dr Tang Wong, Dr Amanda Beech, Auntie Kerrie Doyle, Professor David Simmons, Suzie Neylon and myself.

A Summit presenting the results of the Treatment of Booking Gestational Diabetes Mellitus (TOBOGM) study and discussing the approach to the diagnosis and management of early GDM will be held immediately preceding the ASM led by Professor David Simmons. Further information will be provided as the event draws nearer.

I would like to thank the current board members for all their support this year and for the individual tasks that they perform behind the scenes to maintain and improve our Society.

I wish you all a safe and prosperous festive season and look forward to embarking on our journey in 2022 to continue our mission to improve the outcomes for all women with diabetes during pregnancy.

ADIPS Limited Finance Report 2021

The financial statements for 2021 report that the Society has sustained a loss of \$17,311 as at 30 June 2021 compared with a surplus of \$20,833 in 2020. The retained earnings as at 30 June 2021 were \$128,670 compared with \$145,981 in 2020.

The loss in the current financial period was predicted and expected due to the cancellation of the 2020 ASM and consequently, some expenses but no income from that ASM. The profits from the Annual Scientific Meetings represents a significant portion of the Society's income annually. It is fortunate that the Society sustained a significant surplus in the 2020 financial period that has helped keep the bottom line relatively unchanged since 2019. We remain most grateful to the ATO for providing COVID-19 Business Cash Flow Boosts and JobKeeper payments over the last 2 years

The expenses for the 2020-21 period were mostly comparable with the previous year except with a slightly higher expenditure on the website for the planned upgrade.

The forecast for 2022 should see the Society return to its usual financial outcome at 30 June with a small to modest surplus. ADIPS have received their share of the profits from the ASM held jointly with SOMANZ in July this year – both societies received approximately \$34,000 each. The profits from the ASM and the Membership fees are the two main sources of income and together these funds sustain the operating costs of the Society. The Society receives very little income at present from their investments in the bank.

ADIPS currently has 315 Members with only 61% currently financial for 2021. We ask Members

to please pay their fees as soon as able if you have not already. If you are not financial, you will receive regular email reminders until you pay or alternatively are removed from Membership.


The Society funds remain in a stable position and ADIPS will continue to fund grants and awards as their finances permit.

The trend in the Society's net assets over the past 10 years are represented in Graph A below.

The ADIPS Limited finances are managed by the Finance, Audit and Risk Committee as opposed to the traditional Treasurer role. The two directors during the 2020-21 financial period were Janet Schweda (Lagstrom) and Julia Zinga, who were supported by Suzie Neylon, Company Secretary and Executive Officer who manages the day to day transactions. The Committee oversee the finances and make recommendations to the Board.

The Society financial statements for 2021 were prepared by Tinworth & Co, Chartered Accountants in North Sydney. The report is a summary of the full financial report that is available in the member area of the ADIPS Limited website or upon request.

ADIPS Membership

The Society currently has 314 members listed on their database with 61% currently financial. The implementation of online payments introduced in 2018 has made an improvement in timely payments, however, a substantial number remain unfinancial and will be removed from active membership as many were in 2019.

The membership is composed of a variety of health professionals and researchers with an interest in diabetes in pregnancy including Endocrinologists and other Physicians, Obstetricians, Research Scientists, Diabetes Educators, Dietitians, Midwives, Podiatrists, Pharmacists, and Registrars as well as other interested health professionals.

The benefits of membership include:

- Discounted registration fees to attend the Annual Scientific Meeting
- Opportunities to participate in the organisation of the Annual Scientific Meeting
- Able to apply for a variety of grants and awards including the Graz Clock Award, Emerging Investigator Award, Allied Health Presentation Award and Outstanding Poster Award available at the Annual Scientific Meeting
- Opportunity for junior members to apply for Educational Travel Grants to attend the Annual Scientific Meeting
- Access to ASM invited speaker presentations post conference
- Access to apply for the ADIPS-Novo Nordisk Research Grants for Scientific, Clinical & Education Research
- Receive invitations to comment and participate in review of major clinical guidelines

- Receive regular electronic newsletters containing updates on the latest news and activities of the Society including the wider diabetes in pregnancy community
- Opportunity to nominate for a director position on the board of directors
- Participate in other research and educational activities and projects conducted by ADIPS.

The fees for membership for 2021 were:

Tier 1 – Medical Practitioners - \$198.00 (includes \$18 GST)

This tier includes independent medical practitioners in current clinical practice (eg. Physicians, Obstetricians, General Practitioners etc).

Tier 2 – Researchers, Nurses, Allied Health and Registrars - \$110.00 (includes \$10 GST)

This tier includes Basic Researchers, Registered Nurses, Diabetes Educators, Midwives, Dietitians, Podiatrists, Registrars, Advanced Trainees, and any other health professional (medical or scientific) working in diabetes in pregnancy.

Tier 3 – Students - \$99.00 (includes \$9 GST)

This tier includes medical and scientific students who are enrolled in a training program and have not graduated and are not earning a salary over \$30K.

The fees for international members were the same but excluded the GST component. The membership year is from March to March each year.



The distribution of the total membership throughout Australia and New Zealand is represented in Graph 1 with 34% in NSW/ACT, 25% in Victoria, 19% in Queensland, 6% in Western Australia, 6% in South Australia, 2% in the Northern Territory, 3% in Tasmania and 5% of the total membership are in New Zealand.


Graph 1: ADIPS Membership by State Distribution (2021)



Membership by Occupation

Based on the current information provided to ADIPS by its members, the following broad category occupations are represented: Endocrinologists (31%), Other Physicians (8%), Obstetricians (9%), Diabetes Educators and Nurse Practitioners (29%), Dietitians (6%), Midwives (5%), Scientific Researchers (3%) Other Allied Health (1%) and Trainees, Registrars and Students (8%). Joint Annual Scientific Meeting 2021

Fully Virtual 23-24 July

The planning of the joint ADIPS SOMANZ Annual Scientific Meeting for 2021 during a worldwide pandemic presented some unique challenges for both societies and their organising committees. After careful consideration of the travel restrictions on health professionals, state and territory border closures and the unpredictability of what conditions lay ahead, it was decided that a fully virtual format should be adopted. This was a new concept for both ADIPS and SOMANZ but the result was hugely successful with a record attendance of 560 delegates, predominantly from Australia and New Zealand, with registrants also from the United Kingdom, Hong Kong, Singapore, Canada, India, Switzerland and the United States. The meeting was held over 2 days with 52 oral presentations and 73 poster presentations.

We are grateful to Professor William Lowe Jr (USA) and Professor Lucy Mackillop (UK) our keynote invited speakers who participated in the virtual meeting, negotiating world time zones to interact live with our delegates. Professor Lowe spoke on the HAPO follow up study outcomes. Professor Mackillop spoke on developing digital technologies in obstetric practice.

The diabetes in pregnancy sessions covered a wide variety of topics with a well received presentation by A/Prof Glynis Ross on practical tips for diabetes in pregnancy and technology. The Obesity, Bariatric Surgery and Diabetes session included presentations by Dr Lara Freeman on bariatric surgery and its impact on fertility and Professor David McIntyre on the diagnosis and management of hyperglycaemia after bariatric surgery. JOINT ANNUAL SCIENTIFIC MEETING

Torres Strait Islander Health session included presentations by Dr Diana MacKay on improving care for diabetes in pregnancy in regional and remote Australia and Dr Matthew J.L. Hare on the growing challenge of intergenerational diabetes.

The Emerging Technologies in Diabetes in Pregnancy – Improving Outcomes in the Offspring included presentations by MFM subspecialist A/ Prof Alexis Shub on fetal monitoring in diabetes in pregnancy, Dr Jane Alsweiler on neonatal hypoglycaemia and Cameron Johnson on maternal diet. Professor N Wah Cheung closed this session presenting his long-term research on post-pregnancy interventions for the prevention of type 2 diabetes.

The Hot Topics session included presentations from Professor Christopher Nolan on the pre-analytical glucose handling considerations for the OGTT and Professor David Simmons provided an update on the TOBOGM study.

Professor Stephen Tong from the Mercy Hospital for Women and University of Melbourne, presented the SOMANZ Priscilla Kincaid-Smith Lecture on therapies to prevent or treat preeclampsia.

The Australian Perinatal Network session covered preeclampsia, both clinical and scientific, and the HOW Collaborative session delved into haemorrhage, bleeding disorders and all things haematological. Neurological disorders in pregnancy were covered including

epilepsy, stroke, MS, and cystic fibrosis as well as maternal and foetal outcomes following lung transplant. Other SOMANZ sessions included obstructive sleep apnoea in pregnancy and Professor Lucy Chappell from the UK presenting on COVID vaccination and equity of access in pregnancy.

Our post conference feedback was very positive with many delegates reporting that they had not attended or participated in a fully virtual scientific meeting previously. The modest registration fee was inclusive of post event access to the recorded talks until February 2022 for all delegates. The handbook, including abstracts, will remain available on the Society's websites, and the abstracts will be published in Obstetric Medicine in due course.

We would like to take this opportunity to thank the joint organising committee consisting of Amanda Beech, Bethany Crinall, Arianne Sweeting, Sarah Price, Jade Eccles-Smith, Lindsay Edwards, Natalie Hannan, Stefan Kane, Helen Barrett, and Suzie Neylon.

We look forward to welcoming everyone to Sydney for the IADPSG Meeting to be hosted by ADIPS in 2022 from 17-20 November at the Sheraton Grand Hyde Park.

ADIPS-Novo Nordisk Research Grants

ADIPS were very pleased to be able to offer the research grants again this year with a few minor changes. Instead of offering three (3) research grants, each worth \$6,000, we have offered two (2) grants at A\$10,000 each and invited applications in the broad areas of Clinical, Scientific, and Educational Research. We are very pleased to announce that the two grants that will be funded in this round for A\$10,000 each are:

1. Jincy Immanuel and team for their project: “Evaluation of the performance of blood glucose meters during pregnancy”

2. Rachel Hicks and team for their project: “A mixed-methods pilot study, focusing on the development and implementation of a video on communication methods for HCPs relating to diabetes in pregnancy risks”.





ADIPS Diabetes in Pregnancy Clinical Audit Programme

Professor David Simmons, Board Director
Joined the Board on 27 August 2016

The Australasian Diabetes in Pregnancy Society published a successful pilot study of 3 approaches to clinical audit (paper, stand-alone electronic, networked electronic) across 9 different clinical settings (rural, urban, large proportion of indigenous, New Zealand) linked with a Benchmarking Centre in 2007 [Australian and New Zealand Journal of Obstetrics and Gynaecology 2007;47:198–206]. With the Australian National Diabetes Strategy Goal 4 being to “Reduce the impact of pre-existing and gestational diabetes in pregnancy”, the need to re-establish the audit programme to monitor achievement of the goal, became clear, and ADIPS volunteered to undertake this task. In 2018, the ADIPS Board established the Diabetes in Pregnancy Clinical Audit Programme Working Group which has developed a revised dataset, a process for de-identification of patients and sites, a publication protocol and proposed central data analysis and reporting site protocols. The need for the audit was presented to the Federal Minister, the Hon Greg Hunt at the National Diabetes Forum in October 2018. After the Forum, the Australian Institute of Health and Welfare (AIHW), indicated their interest in assisting with the data repository and to align the ADIPS dataset with other Australian Datasets. However, AIHW also advised that funding would be required to undertake the work.

Since this time, ADIPS has led the development of a proposal for a Clinical Quality Register with the Australian Commission on Safety and Quality in Health Care. The AIHW has provided a detailed proposal for undertaking the work with governance provided by ADIPS with the support of other key organisations. The proposal has now been worked up with the Australian Commission on Safety and Quality in Health Care for funding and the process to raise funds has begun.

In the meantime, ADIPS completed a second pilot Diabetes in Pregnancy Clinical Audit Programme with significant efforts from Professor Flack at Bankstown-Lidcombe Hospital and Dr Jincy Immanuel at Western Sydney University. The results are now available on the ADIPS website and the paper is published:

The eleven volunteer site audits across Australia and New Zealand included 10,144 pregnancies (gestational diabetes mellitus (GDM) = 8696; type 1 diabetes (T1D) = 435; type 2 diabetes (T2D) = 1013). As was expected, pregnancy preparation for women with pregestational diabetes, and birth outcomes for women with GDM, T1D and T2D varied significantly across sites, validating our need for a Clinical Quality Register.
